Total Line Weight and Unit Weight expression fields have been added to the Non Stock Non Shipped Report cursor. These expressions have also been added as columns on the on-screen Results grid.

Modification Processor 35086

Two new fields have been added to the Modification Processor screen for items with the 'Track Length' option selected. The 'Pounds Transferred' field displays the weight of materials transferred to the lower grid. The 'Scrap %' field displays the difference between the pounds transferred to the bottom grid and the weight of the final product(s). These fields will help users determine how much drop is being created during the modification process.

Prompt 46 35165 Scanner Prompt 46 will not allow users to enter negative usage or to produce a negative output quantity. This prevents improper coil tracking issues such as additional coil material being added back onto a coil during assembly.

This enhancement helps improve the accuracy of returning CW items, such as coils.
