## Order Entry

Cash Balance Calculation 35428	New setup option, SOCASHBAL2, will calculate the cash balance on the Sales Order Header screen by taking the balance from the line items (which is a total unshipped amount) + any invoices or POS payments totals taken on the order.

## Sales Tax Automation

Tax Table Master 35657	A 'Clone' function has been added to the Tax Table Master screen to easily copy and make a custom version of an existing tax table. The cloned tax table will automatically be assigned a numeric counter on the table ID, such as _1, _2, and so on. Cloned tax tables are completely manual and will not be updated automatically by any tax update process. Cloned tables must be manually updated or edited. Cloned tax tables are also unique to the specific CID environment where they were created.

Post Load Report (V2) 35661	A new setup option (SEPOSTNODROPRESORT) has been added that will allow running the Post Load report with both the "SO#/Dept" Sort By and "Page Break by Drop No" options selected. Without this setup option, the "Page Break by Drop No" option will not sort by SO#/Dept. This new option only affects the V2 version of the Post Load Report that supports the additional sort options.

Task Status Report 35531	The labels and logic for the new Linked PO Status filter on the Task Status report have been enhanced to make the filter's function more clear. The filter options are now labelled with "Any Open", "All Closed", and "Both". <ul style="list-style-type: none"><li>* "Any Open" shows tasks that have at least one open linked PO</li><li>* "All Closed" shows tasks where all their linked POs are closed or tasks that don't have any linked POs</li><li>* "Both" shows all tasks regardless of linked PO status or being linked to a PO.</li></ul>
