Inventory on Hand Report	The existing ONHANDRECDATE setup option has been expanded to include the receipt date for all inventory items using the 'recdate' field expression on the Inventory on Hand Report. Previously the 'recdate' expression only included logic to handle lot/serial controlled items.	
37296	The 'recdate expression reports the first received date for the item. A new ONHANDRECDATEN setup option has been developed along with a new 'recdateN' form expression for the Inventory on Hand Report. With the new setup option enabled, the new 'recdateN' expression will report the most recent receipt date fore the item on the Inventory on Hand Report. These two setup options and form expressions can be used at the same time to show both the first and the most recent receipt dates on the report.

Part Location (Prompt 86) 36864) Editing Sales Order lines that have been Sent to Production will now update the Part Location (Partloc) SQL table more effectively through the Prompt 86 feature. If the line is edited and the quantity remains the same, no changes are made in Partloc. If the line is edited and the quantity is reduced, the Partloc data is reset to have the new quantity back at the first station. If the line is edited and the quantity is increased, the difference from the original quantity is added to the first station.

Production Work Order 37219	This change adds a new Setup Option and a new Rule Maintenance record to allow auto-assigning materials to a Production Work Order (PWO) even when the available On Hand (OH) is less than the required amount on the PWO.		
	The Setup Option and the Rule are both named PWOSTOCKPM. Both are detailed in the corresponding wiki entries below. The Rule allows users to establish a tolerance level for the auto assignment logic. For example, you can enter '5' in the Allowance (Num1) field to allow auto-assigning an item if the current OH is at least 95% of the needed qty.

Production Work Order 37358	The logic behind the 'Allocate Only' check box on the Assign Serial/Lots tab of the Production Work Order (PWO) screen has been enhanced to provide more visibility on allocated lot-controlled items. The enhancements allow allocated lot controlled material to show completely on the allocate table (SOALLOCATE) and also be printed on the PWO form using the new 'alloclist' expression. These		

enhancements also enable the Coil Status (Prompt 42) scanner function to show the allocated material and the quantity. Material allocated

through the PWO is cleared from the allocate table once the material is assigned, the PWO is assembled, or completed.

Shipping Event - SELINK 37310	SELINK logic can now be used to manage shipping events by sales order lines rather than entire orders and has been expanded for greater visibility and line management. Setup option SELINK5 will enable users to link specific lines to specific shipping events. This will allow users greater control over what is shown on the pre load report, and allow users to move backordered lines and future shipments off the current shipping event.
