Production Work Order 38074	On the Production Work Order (PWO) screen the following changes have been added on the 'Assign Serial/Lots' Tab: * When using the 'Allocate Only' checkbox, the line will highlight Yellow to show that the line is allocated to the job. A new column to show the "Allocated Amount" has been added as well. Multiple line allocations will now show as multiple yellow lines. * The new 'Remove SO Allocation' button will now remove any allocated material from the PWO.			

* The new 'SO Allocate' button will allow users to view all open lots and allocate to the work order, similar to how it is done on the sales order.

On the 'Line Items' Tab or the Production Work Order screen:

* The 'Linked SE' (Shipping Event) will now display as a column in the grid.

Production Work Order Form 38075	New setup option PWOALLOCLIST2 will update the sort and grouping functionality of the Production Work Order screen to allow allocated material to float to a section above the production lines. Qlot, Qqty and Qonhand fields will now show lot, allocated quantity and on hand quantities for allocated material on a production work order. Set up option will use Qlot field as the allocated quantity field instead of the assigned quantity. New sort/group logic assumes PWO form is built with necessary groupings for Qlot.
