GL Groups 39430	New setup option CREDITTOPLANT will use the Producing Plant Location's Cost/Revenue account segments, based on the GL Group assigned to that location. Any GL Group reflexes from the SO Type or the Warehouse combined with item transaction categories (such as frozen digits, etc.) will use the production plant's GL account setups to determine the revenue and cost of goods accounts instead of using the shipping location's GL account setups.

Programs are system-level routines that must be updated manually by ABIS personnel. You must contact your consultant to coordinate updating the associated Program before taking advantage of the enhancement.

Program updates may require system downtime, or may be required to occur outside of business hours.
